When a **noncommercial registered agent** is appointed by an organization, the address of the noncommercial registered agent is required on the document being filed. Contact the noncommercial registered agent to seek the proper address.

Seek the approval of the party before naming them as the noncommercial registered agent on your entity documents. Proof of the approval is not required to be filed with the Secretary of State.
